- c. Seasonal Renter is obligated to comply with all rules and regulations, including the Seasonal Rental Policy. The Board of Directors may expel any renter for any breach of rules, regulations or policies of the Society.

**6. Waiver of Liability**

I understand that it is an express understanding, agreement and condition that Gleniffer Lake Boating Society, its Directors and members shall not be liable, either together or separately, or any combination thereof, for any damage suffered by me or my guest or guests for any loss whatsoever, including personal injuries arising out of or related to any default of the Society or any representative or contractor of the Society, whether resulting from negligence or otherwise.

## **Seasonal Marina Access for a Non-Member**

Seasonal Marina Access will be allowed for parties renting properties within Carefree Resort pursuant to the following conditions:

1. All parties requesting Seasonal Access must be renting a lot within Carefree Resort. A copy of the Carefree Resort Rental Agreement must be presented in order to qualify for seasonal access.
2. Only one Seasonal Access per lot per year will be permitted.
3. Seasonal Access is for one complete season only (June to September). No partial season rentals will be allowed. Seasonal Rentals must be applied for each year,
4. Non-members must adhere to all by-laws, regulations and policies. Any party who contravenes these regulations will lose all privileges without compensation.
5. No trailer parking will be permitted for Non-Members. Day parking is permitted on a first-come-first served basis.
6. Both an identity sticker and a current year sticker must be on the trailer before access to the marina is allowed.
7. All applications are subject to approval by the GLBS Board of Directors.
8. A maximum of ten (10) applications per year will be approved.
9. Any and all damages caused by the Non-Member will be their sole financial responsibility.
10. The annual fee for Seasonal Access will be equal to the Basic Member fee plus a yearly administration fee to be determined by the GLBS Board of Directors.

**Any violation of these regulations will result in immediate revocation of all privileges with no compensation of fees.**
